## President of the Robert Koch Institute in Berlin

The Robert Koch Institute (RKI) is the central research and reference institution of the Federal Government in the field of disease surveillance, control and prevention, communicable diseases and other health risks. It reports to the Federal Ministry of Health and has approximately 1,000 employees.

The RKI's tasks include: recognising health-related problems that can affect the population, compiling scientific findings as a basis for health policy decisions, producing scientific analyses, evaluations of highly dangerous, high-prevalence diseases, or diseases of major public or health policy significance and recommending concepts for their control and prevention.

The Institute advises the Federal Ministry of Health, other Federal and Land ministries as well as the public health service and furnishes the expert public with scientifically sound and unbiased information. It supports the competent intuitions at Federal and Land level in the recognition and management of health-related threats as well as with crisis management.

With a view to recognising health threats and risks, the RKI exercises a central function within the framework of an early warning system. The Institute also increasingly assumes international obligations and co-ordination tasks, for example vis-à-vis the European Centre for Disease Prevention and Control, the EU and WHO and collaborates in their committees and other relevant bodies.

Several expert commissions, some of which are set up on a statutory basis, as well as a network of National Reference Centres and consultant laboratories are based at the RKI. The recommendations elaborated by its commissions shape central areas of the health care services.

Furthermore, the Robert Koch Institute conducts application and response-oriented biomedical research at the highest level. For this purpose, it has extensive and modern laboratory space at its disposal. A new building housing BSL-3 and BSL-4 laboratories will be completed in the very near future.
